Under the direction of the Tribal Administrator this position will primarily be responsible to manage the Tribal Natural Resources department to assure the protection of the Tribes environmental resources. Successful candidate must have the knowledge of research methods, statistical analytical, and reporting techniques; environmental preservation planning; interpersonal skills using tact, patience, and courtesy; correct English usage grammar, spelling, punctuation, and vocabulary; conflict resolution practices; principles of administration including budget preparation and controls; develop, organize, and implement training programs for various levels of staff; community resources, educational, and employment opportunities. Must have the ability to apply cultural sensitivity to Native American programs; maintain confidentiality; apply principles of management; apply effective time management and be able to meet critical time-lines; assess, plan, evaluate, and implement program activities per program standards; communicate effectively, both orally and written in a professional manner; prepare clear, concise, accurate records and reports; provide work direction and guidance to others; ensure smooth and efficient office and program operations; work independently on assigned duties; develop, manage, and review department budgets; operate a variety of office equipment computer and software; problem solving and strategically resolve conflict; interpret, apply, and explain rules, regulations, policies and procedures; establish and maintain, cooperative and effective working relationships with others; build good working relationships with co-workers, subordinates, clients, and other stakeholders.

- High School Diploma or equivalency certificate required and eight (8) years in Environmental Science, Chemistry or related field plus five (5) years increasingly responsible experience in the management of TANF programs or related field.
